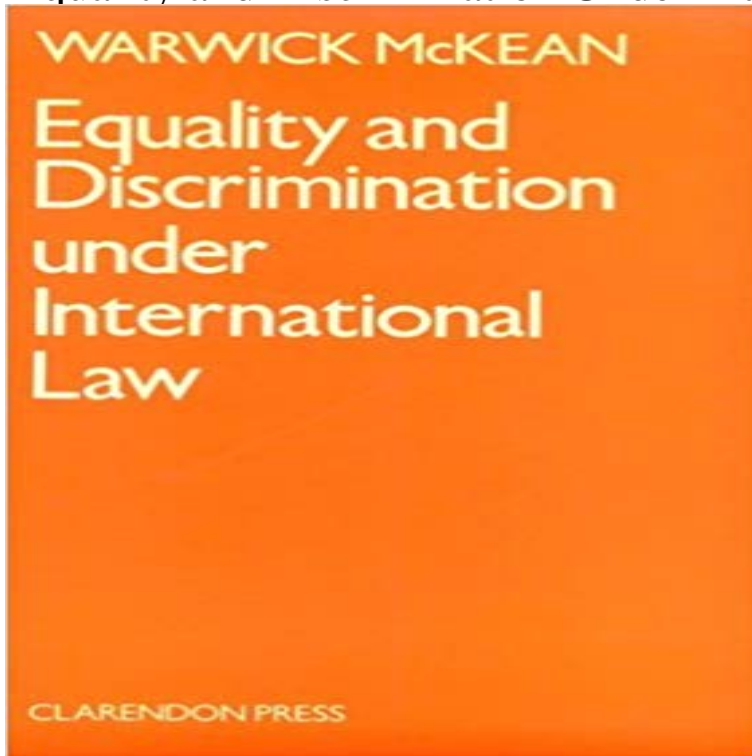


Equality and Discrimination Under International Law
